SEPTEMBER 2009 QUARTERLY REPORT

The Board of Odyssey Energy Limited (“Odyssey” or “Company”) is pleased to present its September 2009 quarterly report.

As previously advised, the Company has reviewed its ongoing cash outflow requirements resulting in overheads and exploration expenditure being substantially reduced.

Activities on the Company’s McClain County Project are currently being limited to desktop reviews of geological information. The Board will re-assess this approach should the gas sector market in the USA materially change.

The Company is focused on identifying new business opportunities in the energy sector, and examined a number of oil and gas and other energy projects during the quarter. Further announcements will be made to the market regarding new business activities as required.

As announced in late 2008, the Company completed the sale of its subsidiary OEL Operating (USA) (“OEL”) to Marion Energy Limited (“Marion”), in consideration for 27.5 million Marion Shares (ASX Code MAE). These shares were released from escrow on 4 June 2009.

The sale of OEL to Marion has reduced the Company’s working capital requirements, and as a substantial shareholder in Marion, provided Odyssey with exposure to Marion’s cornerstone project, Clear Creek.

Marion announced during the June quarter that the major global corporate advisory firm, Goldman Sachs, had formally commenced the process to find a suitable buyer or merger for Marion and/or its assets.

Marion also announced a new reserves report (see ASX release dated 30 April 2009) with revised Proved and Probable (2P) reserves of 225 Bcf (3P reserves are 243 Bcf). The revised reserves report reflects the reduced gas prices since the last reserves report prepared in mid 2007.

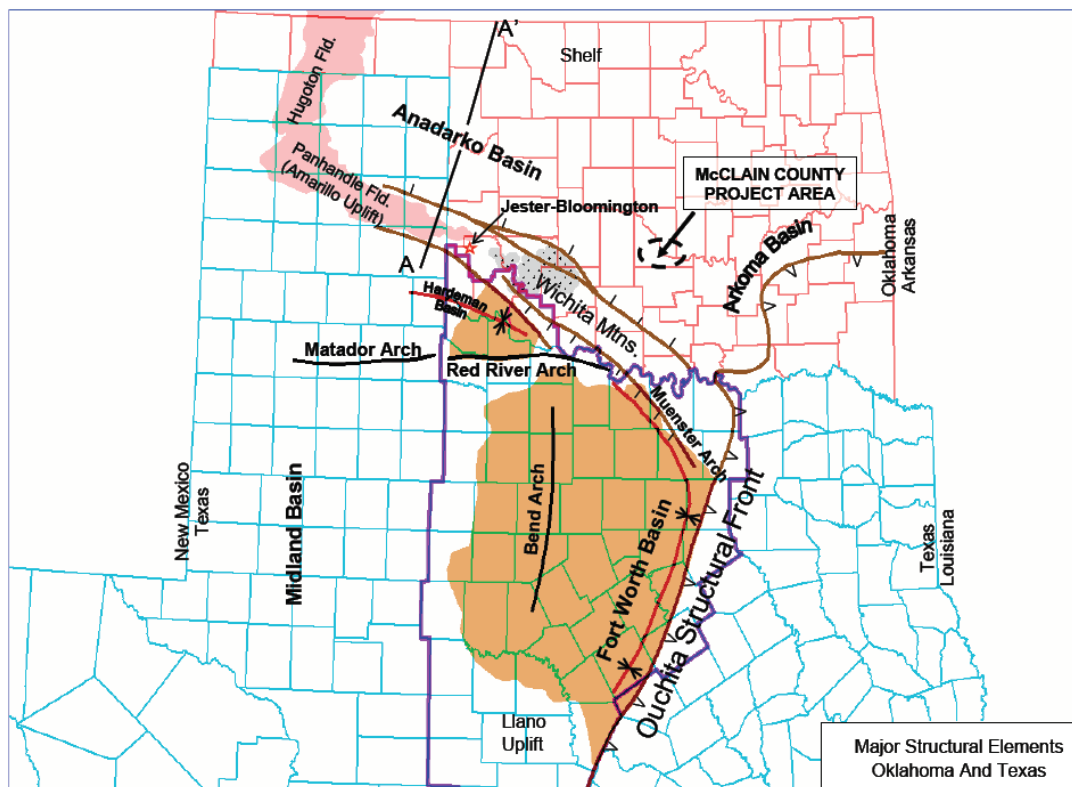
In August 2009 Marion announced that the sale process was ongoing and that it had recommenced operations at Clear Creek to bring wells back into production.

Marion has recently completed a share placement and has advised that it is undertaking a 1 for 2 rights issue. The Board will make a decision on participating in the rights issue when further details are announced by Marion, including the rights issue timetable and any updates on operational and corporate activities. However, given the current level of funding for the Company, it is unlikely that Odyssey will participate in the rights issue.

Operations - McClain County Project – Odyssey 50% WI:

In mid 2008 Odyssey acquired a 50% working interest in a new project area in Oklahoma comprising 1,626 gross acres, and targeting gas and associated oil in the Woodford Shale at between 6,000 and 8,000 feet.

The Company is undertaking desktop geological and other technical studies which will continue through 2009, initially focusing on the results achieved by other operations in the area.
